**<1> Eastertide Greetings and Update by Jim Gulley, UMMA chair**

Eastertide greetings! Lent and Easter took on added significance for me, given my personal experience with the Haitian earthquake. I continue to thank God for my life, health and strength. Let me share two messages of hope.

The first message of hope comes because we trust in God, whom we know through Jesus, the Christ. My pre-Easter experience in Haiti included being entombed with five colleagues on the floor of the Montana Hotel for 55 hours. Four of us received the gift of a new life, bestowed upon us graciously - unearned, unmerited and with deep humility. Two of us, Rev. Sam Dixon

and Rev. Clint Rabb, claimed the fullness of Christ's resurrection for they trusted, as we all did *"that neither death, nor life, nor angels, nor rulers, nor things present, nor things to come, nor powers, nor height, nor depth, nor anything else in all creation, will be able to separate us from the love of God in Christ Jesus our Lord. (Rom 8:38-39)*. Through my tears of loss I claim the hope of the resurrection, knowing that Sam and Clint remain alive in and with Christ, our Lord. I continue to pray that Cindy Dixon and Suzanne Rabb may likewise claim that same hope.

Beyond our personal losses, let us never cease to pray for the Haitians whose lives have been totally turned literally upside down and inside out. As I am currently in Haiti, I can confirm that Haitians are now rebuilding, once again, but the road is oh so long. May we never abandon our commitment to walk with them to the end of our lives into a *new Haiti*, built together through the grace of God.

A second message of hope comes with the election of Thomas Kemper as General Secretary of the General Board of Global Ministries (GBGM). You should have received his letter of welcome to the whole missionary community, which speaks for itself in its affirmation of the centrality of missionary personnel in the life of Global Ministries, even as its role may change (see copy of the letter on the UMMA website: <http://www.umma-global.org>).

Let us live out of God's resurrecting and transforming power trusting that we all - GBGM staff, board members and missionaries alike - will step into the new future of hope and promise that God offers us as we serve faithfully together. *O God, let me, let others all do our part!*

## <2> **GBGM Board of Directors Meeting** - Notes by J Dwyer, J Hill, and C Whitlatch

The GBGM Board of Director's Meeting , April 12-14, was enveloped by well thought out and inspiring worship services. Rev. Jim Gulley offered the reflection at the opening service in which Sam Dixon and Clint Rabb were remembered. The second time of worship was a service of blessing and affirmation of Thomas Kemper as the new General Secretary of GBGM. In attendance from UMMA were, in addition to Jim Gulley, Joyce Hill, Cathy Whitlatch, Jim Dwyer and Fred Price.

### **GBGM President's Address**

Bishop Bruce Ough reflected on Matthew's resurrection story about the women who were at the tomb. He commented that the women holding onto Jesus' feet "were trying to get a grip on reality..." Bishop Ough feels this is a good image for GBGM – we need to hold onto Jesus as we go through the transition, transformation, trauma, and tragedy. Furthermore he urged GBGM to truly lead United Methodists by being a resource to individuals, conferences, churches, and institutions already in mission. ### **General Secretary's Report**

During his address, Thomas Kemper commented that he is strongly committed to the four United Methodist focus areas. Kemper also called for:

- (1) United Methodist mission culture that is spiritually connected and operationally collaborative;
- (2) a vital, Wesleyan mission theology that becomes the foundation for our strategic mission plans;
- (3) an international, ethnically diverse community of effective, well-trained and well-supported missionaries, assigned in collaboration with mission partners around the world; and
- (4) ecumenical mission.

## **Task Force Reports**

Reports were given by the chairpersons of the Governance and Implementation Task Forces set up after the 2009 Operational Audit of the General Board of Global Ministries. The Implementation Task Force reported its progress on the 216 recommendations. The overall Governance Task Force's final report given by chairperson Mrs. Inelda Gonzales was "received" but not adopted by the Directors. Mrs. Gonzales reported a lack of consensus on level of representation the Women's Division level of representation on GBGM's Board of Directors and on the draft mission statement. Some perceived a conflict of interest in Mrs. Gonzales serving both as President of the WD Board of Directors and as Chair of the Governance Task Force that was to decide WD representation.

The draft mission statement prepared by the Mission Development Committee (MDC), with input from Dr. Phil Wingeier-Rayo, was also "received" and referred to the Executive Committee for further action. Valerie Stultz, MDC chair, celebrated the process but noted that with the dissolution of MDC the Executive Committee will be responsible for deciding on the mission statement process in the future. There was much discussion about what was needed in the theology of mission statement. The planning functions of the Mission Development Committee were also transferred to the Executive Committee.

Ms. Jerald S. McKie (Jeri) continues to serve as interim Associate General Secretary of the **Mission Relationships** sub-unit until permanent assignments can be made to positions.

The **Justice and Discipleship** sub-unit of Mission and Evangelism is currently unfilled.

**Four Areas of Focus** - Groups were formed from the final Mission Development Committee meeting on Tuesday afternoon to review GBGM's work on the Four Areas of Focus which originated from the Connectional Table (2008 General Conference). Joyce Hill attended the session on ministry with the poor; Jim Gulley, global health (UMCOR); Jim Dwyer, congregational development; and Cathy Whitlatch, leadership development.

## **Meeting with GS Kemper, staff and directors**

UMMA members met with General Secretary Thomas Kemper, cabinet and other staff members, and several directors for approximately 1-½ hours following the close of the Director's meeting. UMMA had several issues to address which included:

- finding a place at the table for missionary community;
- the desire to have the MIR role situated in the office of the General Secretary,
- a desire to coordinate and with GBGM cooperation to hold bi-annual Mission Forums,
- the need to have a data base of the whole missionary community (active, inactive, and retired) as persons who are interested in GBGM, appreciated by GBGM, and who can be advocates in their Annual Conferences as well as agents of hospitality for visiting missionaries;
- a new look at missionary pensions and health benefits,
- and the different categories of mission service.

In the future, UMMA has been asked to work with the office of Mission and Evangelism to draw up the agenda at least 30 days prior to the meeting so that all will have a chance to study the needs. Thomas Kemper stated that he thinks we should always be able to find a 1-½ hour block of time to meet at each board meeting.

### **Other notes**

As a long-time observer of Board meetings on behalf of UMMA, Jim Dwyer found the spirit of the meeting to be more positive than any previous meeting he has attended. Although some found it off-putting, the fact that the Directors were able to openly express the sense of distrust of one another which has often remained unexpressed without getting angry with one another can also be seen as a first step toward a new level of cooperation and collaboration among the directors and of the Board with the church

Another remarkable aspect of the meeting was the presence of three representatives of large United Methodist local churches whose full-time mission directors are part of an association-information of persons in similar positions across the country and across denominations. The three were Jonathan Bell, director of mission ministry at the United Methodist Church of the Resurrection <[www.cor.org](http://www.cor.org)>, Leawood, Kansas; the Rev. Lynette Fields, executive director of servant ministries at St. Luke's United Methodist Church <[www.st.lukes.org](http://www.st.lukes.org)>, Orlando, Florida; and Jeff Jernigan, chair of the Global Ministries team of the North Georgia Annual Conference and a leader in McEachern Memorial United Methodist Church <[www.meachernumc.org](http://www.meachernumc.org)>, Powder Springs, Georgia. This seemed to be directly related to Bishop Ough's vision of GBGM as increasingly a mission resource rather than sole mission agency of the church. Lynette's first comment was one often heard in various mission settings: "I started in mission as a US-2."

Those who have followed previous Mission Personnel Committee meetings and the reporting of missionary statistics will find Bruce Griffith's new formulation of interest.

NEW YORK (UMNS)—Through his United Methodist connections, Thomas Kemper, 53, is a citizen of the world. His passport is German, but he spent two years managing a youth hostel and working with Vietnamese boat people in London. He took up residence in an African village to do research for a master's thesis and spent nearly a decade as a missionary in Brazil. On March 15, he became the top executive of United Methodist Board of Global Ministries.

**<5> UMMA Representing Missionaries for 15 Years by Richard Schwenk, editor**

In 1995, Robert Harman, last Associate General Secretary of the now extinct World Division, suggested to me that missionaries should get organized so they would have a unified voice. Under the re-structuring plan of the GBGM in 1996, there would no longer be Missionary Consultations each year with representatives from various regions who were on home assignment. As Missionaries in Residence, my wife, Caring, and I compiled the first long email list of missionaries so we could more easily gather their ideas and objectives of what became UMMA. The response was overwhelming with almost 500 paying dues of \$25 each in 1996.

Now, 15 years later, our missionary force and finances have dwindled. UMMA is making great progress, but needs more membership support. A major cost is transportation subsidies for our representatives to attend meetings. They volunteer their own funds to make up the difference for transport, food and other costs. So your help in paying your dues is greatly appreciated.

Membership dues for 2010 are being received now.
